1965

The March meeting of the Local Association of Rangers, Guides & Brownies was held March 22 at Park Hotel. Also a committee was formed to find a new Commissioner. Mrs. Welter, Mrs. Tipper, Mrs. Robideau and Mrs. Patterson volunteered to go on this committee.

A discussion was held concerning cookie day. Mrs. Patterson volunteered to obtain a map of the city for zoning the city for depots. Eight homes were volunteered for depots.

Also to ask Westons to change advertising to May 8. Our bake sale will be held March 27 at Midwest Electric Store from 1-5 p.m. Mrs. Tipper said she could bring 2 card tables and Mrs. Welter said she would bring 1 card table and a plastic tablecloth. Volunteers to help at the bake sale were Marge Robideau, Mrs. Ford, Isobel Patterson, and Mrs. McKie.

Mrs. Welter adjourned the meeting. Next meeting to be held April 26 at 8 p.m. at the Park Hotel.

An Executive meeting was held April 13 at the home of Mrs. Wallace to discuss the financial arrangements for delegates going to Convention in Edmonton.

Mrs. Welter made a motion that we send Mrs. Wallace, Mrs. Widdifield, and Mrs. Nelson to Edmonton to the convention. Seconded by Mrs. Wallace.

Mrs. McKie made a motion that the delegates be given \$100 for convention expenses. Seconded by Mrs. Welter. Lunch was served by the hostess following the meeting.

The April meeting of Local Association of Rangers, Guides and Brownies was held April 26 at 8 p.m. at the Park Hotel.

Minutes of the last meeting and executive meeting were read. Treasurer's report was read and the balance on hand is \$102.20. The bake sale held at Midwest Electric was \$80.80. Mrs. Welter seconded the Treasurer's report. A letter from the City of Grande Prairie was reading [sic] approving our Cookie Day on May 8. The secretary was asked to write letters of thanks to Midwest Electric and Oliver Furniture. Mrs. Welter made this motion.

A discussion concerning cookie day was held. Cars and drivers were enlisted for Cookie day. For transporting girls and to pick up money after the sale.

The meeting was adjourned by Mrs. Wallace. Next meeting will be held May 31 as the regular meeting night falls on May 24 holiday.

A meeting of the Local Association of Rangers, Guides and Brownies was held June 28 at the Park Hotel. A discussion of cookie profits was held and the meeting at large approved the handling of cookie money for girls to be given to them if needed during the summer before all cookie money is in.

Mrs. Welter made a motion that we advance money for transportation or arrange for a ride for one of our Rangers to go to camp at Tangletrees. Maxine Tipper seconded the motion. The secretary was asked to write a letter of appreciation to Joan Dredge.

Next meeting to be held Sept. 27. It was suggested that we invite leaders to our first meeting.

Isobel Patterson adjourned the meeting.

The September meeting of the Local Association of Rangers, Guides and Brownies was held September 27 at the Park Hotel with 13 members attending. The minutes of the last meeting were read and approved. Our treasurer was sick and Mrs. Moore gave a financial report. L.A. has \$37.00 in funds. Approximately \$40.00 will be given to each group.

The Secretary read a letter of resignation from Mrs. Joan Dredge. We were sorry to see her go.

Mrs. Moore gave us a list of Brownie packs and where help is needed. Leaders and helpers are needed to get some of the packs going ahead. Anyone having uniforms for leaders, please contact Mrs. Moore or Mrs. McKie.

Mrs. Grace Wallace made a motion that we hold a Bake Sale or Rummage Sale to start a project to buy material to make uniforms or buy uniforms for leaders. Seconded by Maxine Tipper. Mrs. Welter contacted Eaton's in Edmonton, Children's Dept, downtown store. They have new-old style brownie uniforms for \$3.00. Please let leaders know if anyone can arrange for a uniform for a Guide helper.

Mrs. Isobel Patterson made a motion that we write a letter to Mrs. Lien of Valleyview asking her to consider taking the job of Commissioner. Seconded by Mrs. Rhode. Approved by L.A. members.

Mrs. Maxine Tipper made a motion that we give permission to Mrs. Grise to sell handbooks to Brownies for .50¢ instead of \$1.60. Balance to be paid by pack funds. Mrs. Tipper made a motion that we hold a rummage sale to raise money for Guides uniforms. Mrs. Ford seconded the motion.

Mrs. Wallace made a motion that we buy Mrs. Nelson a gift up to the value of \$30.00.

The meeting was adjourned by Grace Wallace.

Next meeting to be held October 25 at 8 p.m. at the Park Hotel. Mrs. Welter declared minutes approved with amendment to minutes.

The October meeting of the Local Association of Rangers, Guides and Brownies was held October 25 at 8 p.m. with 15 members attending. The secretary read the minutes of the last meeting and made amendments. Mrs. Welter declared minutes approved with amendments to minutes. Mrs. Widdifield gave the treasurer's report and financial statement. Balance on hand is \$88.35. The rummage sale brought in \$65.60 with the Rangers portion \$11.00 leaving \$54.60 to the L.A. Maxine Tipper declared the treasurer's report approved. Correspondence was read by the secretary. Mrs. Moore read a letter from the Centennial Committee. Mrs. Welter volunteered to attend Oct 27 Nov 9 meeting to bring information back to our next meeting. Secretary will write application to Centennial Committee.

We have no Montrose pack now, but girls will be going to St. Joseph's which is now Pack 1. Mrs. Widdifield asked about distributing money from Cookie Day. Each pack will get approximately \$30.00. Mrs. Dingly's pack will go to St. Joe's Pack 1.

Mrs. Tipper made a motion that the L.A. put an ad in the Herald Tribune for Brownie and Guide uniforms for sale. Call Mrs. Nelson between 7-9 evenings 2207.

Grace Wallace made a motion that we order 6 - \$1.00 teaspoons to be given to leaders leaving packs or companies.

A discussion of leaders and packs gave us some information on the type of leaders needed.

A suggestion was made that the Guiders club let us know if any leaders are in need of uniforms. L.A. is ask [sic] Ranger captain if Rangers would like to handle publicity for Guides and Brownies. Mrs. Nelson, guide captain represented the Guiders Club. Each meeting we will have a representative from their club. Problems and suggestions will be brought to us from the leaders.

Mrs. Sivak, Brown Owl from St. Gerard's gave us a few words about the new Brownie program. All leaders are enthused about it. Most of the tests are done by games. Mothers may be called on to help with the Brownie testing. The mothers thanked Mrs. Sivak for her talk. Afterwards the mothers discussed the program with Mrs. Nelson and Mrs. Sivak. Badge Secretary Mrs. Wallace had an interesting display of new Brownie and Guide uniforms, books, pamphlets. She answered questions from mothers about ordering goods.

The meeting was adjourned by Mrs. Tate. Next meeting on November 29 at 8 p.m. Park Hotel.

An executive meeting was held December 9, at 8 p.m. at the home of Mrs. Isobel Patterson.

Maxine Tipper made a motion that we pay the Royal Canadian Legion for the wreath presented at the cenotaph on November 11. Seconded by Betty Welter. Mrs. Widdifield asked about the L.A. census [sic]. Forms will be sent in to Edmonton. Census [sic] forms and money will be collected from leaders before Christmas. Mrs. Moore asked about a nominating committee. Up for election are Vice-President, Treasurer, Secretary, and ~~Publishing Convener~~.

Annual Report

The Local Association of Rangers, Guides and Brownies has been busy this past year. To start the year ~~will~~ we convened a supper for the training session on March 3. Also donated \$10.00 to Speke Hall for use of facilities for Guide meetings etc. Committee was formed to find a new Commissioner. A bake sale was held March 27. \$80.80 L.A. donated \$100 to delegates to pay expenses at Convention in April. Cookie day was held May 8 in city.

Advanced money to Ranger to go to camp at Tangletree. Bought a present for Mrs. Nelson and held social gathering before her departure for High Prairie. Rummage Sale was held in September, brought in \$54.60. This has been a year of new groups and some new leaders.

The January meeting of the Local Association of Rangers, Guides and Brownies was held January 31 at the Park Hotel with 7 members and 2 leaders. The secretary read the minutes of the last meeting and an executive meeting. Seconded by Betty Welter. Mrs. Widdifield read the treasurer's report. We now have \$78.30 cash on hand. Treasurer's report seconded by Maxine Tipper. Betty Welter made a motion that the Secretary write to Edmonton and inquire if a Medal of Merit or certificate could be presented to Mrs. Dinzey for exceptional service. Maxine Tipper seconded the motion. Betty Welter gave a report on the meeting of the Centennial Committee. Bear Creek Park is the project for Grande Prairie with \$35,000 allocated. Museum will also be built there.

Maxine Tipper made a motion that we have a picture of a Ranger, Guide and Brownie in the paper with caption "We Need Leaders." Also the names and phone numbers of ladies to be contacted. Seconded by Mrs. Morris. A suggestion was made by Betty Welter from the Local Association that Grande Prairie groups would not sell cookies on Cookie Day, subject to the wishes of Guiders for selling on their own.

The Secretary read the Annual Report and Mrs. Widdifield read the Treasurer's report. Seconded by Betty Welter. Secretary was asked to write a letter of thanks to Mr. Reuben Stark for auditing the books.

The Annual Meeting was held after the regular business meeting. Nominating committee submitted this slate as follows.

Mrs. Morris nominated Maxine Tipper as Vice-President. Nomination from the floor. Seconded by Betty Welter. Mrs. Lerseth moved that nominations cease. Betty Welter seconded. The meeting unanimously approved the nominating slate. Betty Welter thanked the retiring Secretary and executive for their work in the past year. Mrs. Lerseth adjourned the meeting.

An executive meeting of the Local Association of Rangers, Guides and Brownies was held at the home of Mrs. H. Tipper at 8 p.m. Feb. 24 with eight present.

There was discussion about uniforms for leaders and it was decided to set up a uniform registry. Mrs. Maxine Tipper volunteered to set this up.

It was decided to buy Mrs. Dinzey's uniform for Fran Yauch at a cost of \$4.00. This includes dress, belt and scarf.

It was also decided to purchase a suitable pattern in size 12, 14, 16, & 18 and enough material for five dresses and the necessary sewing notions – Also 5 belts, hats & ties.

The secretary was requested to write to City Council for permission to hold Cookie Day in Grande Prairie May 7, and to the Provincial Office to request a training session & set date for same and also for information on a correspondence course for leaders.

General discussion was held on fund raising with the possibilities of bake sales and coffee and lunch at the T? Fair to be investigated.

Mrs. Tipper moved that the letter to Mayor Repka from the guides be disregarded as courtesy to good public relations. Seconded by Mrs. Welter. Carried.

Meeting adjourned by Mrs. Wallace.

The February meeting of the Local Association of Rangers, Guides and Brownies met on Feb. 28 at 8 p.m. 6 members and 1 leader present.

The secretary read the minutes and also those of the annual meeting. Seconded by Mrs. Widdifield. The treasurer's report of \$98.30 was given by the treasurer. Seconded by Mrs. Tipper.

Moved by Mrs. Tipper and sec. by Mrs. Forglen (sp?) that a donation of ten dollars (\$10.00) be given to Christ Church Anglican for the use of Speke Hall for Guide meetings. Carried.

Mrs. Barr moved that the eighty dollars (\$80.00) from the Montrose pack be absorbed by the L.A. for use in the purchase of 5 uniforms. Seconded by Mrs. Forglen. Carried. Mrs. Tipper moved that a letter of appreciation be sent to the Herald Tribune for the excellent coverage given to History Day & our need for leaders. Seconded by Mrs. Barr. Carried.

Maxine Tipper moved that letter of appreciation be sent to Mrs. Grace Wallace, Mrs. McKie, Mrs. Dinsey, Mrs. Hall & Mrs. Grise in appreciation for services to the G.P. Guide movement and that spoons be presented to these people at a later date. Seconded by Mrs. Barr. Carried.

Maxine Tipper reported on the phoning committee – a total of 18 phoners.

Mrs. Barr moved that Mrs. Mantel be the representative from the L.A. to the Guides meetings. Sec. Mrs. Forglen. Carried.

It was requested that the Secretary write to Edmonton requesting Warrant nomination forms and information on the sponsorship of Brownie packs by organization eg. Church groups.

Mrs. Forglen moved that a Bake sale be held March 19 1:30 p.m. in McLeod's store (Convenor to be Mrs. Barr). Seconded by Mrs. Tipper. Carried. Mrs. Forglen adjourned the meeting.

The April meeting of the Local Association of Rangers, Guides and Brownies met in the Park Hotel with 9 members & one leader present.

Minutes of the February meeting were read and accepted. Financial statement was read by Mrs. Widdifield. Cash from bake sale was \$38.85 total. Bank balance 195.09. Seconded by Mrs. Tipper. Carried.

Correspondence was read. Mrs. Patterson asked that the secretary send a letter of thanks to McLeod's store for use of the store for the Bake Sale.

There was inquiry re correspondence re a medal or certificate of merit for Mrs. Dinzey. No reply has been received so the secretary was asked to write to Edmonton office again. There was discussion about sending delegates [sic] to the Guides Convention in Edmonton in May. Two delegates are willing to go. The expenses would be approximately \$100.

Mrs. Patterson moved that the proceeds from the Bake sale formerly allocated towards the purchase of uniforms be reallocated towards sending delegates to the Guides Conference in Edmonton and that other moneys formerly allocated towards uniform purchase up to a total of \$100 be used to send Guides to the conference. Seconded by Mrs. Barr. Carried.

Discussion took place regarding camping. Mrs. Gourlay reported on Cookie Day and agreed to look after the money in this connection. There was discussion on Ranger rally & gifts for departing leaders. Maxine Tipper moved we order one more spoon. Seconded by Mrs. Barr. Carried.

Mrs. Patterson moved the meeting adjourn.

The regular May meeting of the Local Association of Rangers, Guides & Brownies was held in the Park Hotel May 27, 10 members and 2 Guides present. April minutes were read and adopted. The Treasurers report was read – Bank balance of \$392.64 of which cookie costs must be subtracted.

Correspondence was read concerning medal of merit for Mrs. Dinzey. The Secretary was authorized to phone Mrs. Nelson in High Prairie to obtain the necessary information for the form. Considerable discussion centred around a proposed Mother and Daughter Banquet. Mrs. Tipper moved that suitable arrangements for an economical mother and daughter banquet be made. Time and date to be announced. Mrs. Forgen seconded the motion. Carried.

Maxine Tipper volunteered to make necessary inquiries. Mrs. Sivak reported a very successful cookie day – all cookies sold. Mrs. Todd gave a most enthusiastic report of the Guides Conference in Edmonton which Mrs. Beatty and she had attended. She requested the L.A. request Mrs. Dorothy Smyth to come to G.P. to attend a weekend camp July 1st and felt accommodation could be arranged at the Presbyterian camp at Saskatoon Lake. Mrs. Todd reported that provincial headquarters had indicated they would pay Mrs. Smyth's expenses. The camp would accommodate 18 girls. Provincial headquarters also indicated they would be willing to send a trainer team to Grande Prairie in the fall. This report was discussed fully and felt by the meeting to be most beneficial.

The Local Association of Rangers, Guides & Brownies met Oct. 18th with 10 members and 1 Guider present and Mrs. H. Leppie [sp?] in the chair. Minutes were read and adopted. The treasurer's report was read showing a balance of \$70.69. Mrs. Patterson seconded Mrs. Widdifield's report. Carried.

Considerable correspondence was read – much of it accumulated over the summer. It was reported that Mrs. Todd had allowed her name to be submitted for District Commissioner.

Mrs. Tipper reported that all packs (7) & companies (2) & one Ranger group was staffed temporarily but that another Guide leader was needed to replace Mrs. Tissington. Mrs. Audrey Anderson is the new badge secretary. The secretary agreed to write Mrs. Mantell a letter of appreciation for her work as Badge secretary.

There was discussion of the fee increase to \$1.25 and it was decided to ask the packs to take the extra 25¢ from pack funds rather than ask the children for extra money.

It was moved by Mrs. Patterson and seconded by Mrs. Hennig that pack No 7 be given \$10.00 from the L.A. to help with initial expenses. Carried.

Mrs. Forgen moved that a wreath up to the cost of \$10. be bought for laying at the Cenotaph on Nov. 11th. Mrs. Penner seconded. Carried. Mrs. Sivak agreed that the Guides would appoint someone to lay the wreath.

There was discussion of the suggested Centennial project – a [?]. It was suggested that the Guides & Brownies co-operate with cubs and scouts in a joint [?] project.

Mrs. Tipper reported on investigation of former guide property, which no longer was available. Mrs. Patterson and Mrs. Morris were appointed to investigate all possibilities.

The training session tentatively set for Nov. 11 & 12 was discussed at length. Billets and food must be provided. Mrs. Patterson and Morris will look after availability of space, Mrs. Welter, Forgen & Lerseth, arrangement for food.

There was lengthy discussion about the W.I.'s request for the L.A. to provide a tea on Nov. 19 for their display of handicrafts. It was decided that the L.A. would not undertake this venture because of prior involvement with the training session.

Meeting was adjourned on a motion of Mrs. Hennig.
